

## PROJECT GRANTSMANSHIP

**PROJECT GRANTSMANSHIP** helps to strengthen small to medium-sized community-based organizations in Los Angeles County by training their leaders to: 1) plan more effective programs, 2) produce logical and compelling grant proposals, and 3) collaborate more effectively with colleague organizations. Begun in 2008 as a partnership of the Annenberg Foundation, California Community Foundation, and The Grantsmanship Center, PROJECT GRANTSMANSHIP rapidly expanded to include Dwight Stuart Youth Fund, The Ralph M. Parsons Foundation and S. Mark Taper Foundation as supporters.

### HOW DOES PROJECT GRANTSMANSHIP WORK?

The project partners underwrite up to 90 percent of the tuition for eligible nonprofit staff or Board members to attend The Grantsmanship Center's 5-day *Grantsmanship Training Program*. This very interactive training uses the Center's *Listen & Discuss, Do & Review*® curriculum where participants gain skills and increase knowledge in program planning, proposal writing, finding appropriate funders, working with funders as partners, and reviewing proposals as funders do. The last day of PROJECT GRANTSMANSHIP includes a Meet-the-Grantmakers Q&A with foundation representatives.

### WHO MAY ATTEND?

Board members or paid staff of organizations based in and serving Los Angeles County with IRS 501(c)(3) public charity status and annual budgets at or below \$14.5 million are eligible. Each unique nonprofit organization may send up to two participants over the lifetime of PROJECT GRANTSMANSHIP. Sorry, volunteers and independent consultants are not eligible.

### WHAT'S THE COST?

PROJECT GRANTSMANSHIP charges only \$200 or \$300 per person, depending on their organization's budget. Paid registration includes tuition, the textbook, *Grantsmanship: Program Planning and Proposal Writing*, and six months of Alumni Membership benefits. The standard fee for this package is \$1,240 per person (\$1,195 tuition and \$45 textbook + S&H).

Participants who fully engage in the training are eligible to receive a 50% rebate of their fee after they complete follow-up requirements which include submitting a draft proposal for review and completing an online survey six months after class.

### OTHER REQUIREMENTS?

Because of the comprehensive nature of this training with many segments building upon one another, as well as the team approach used for a major project, each participant must commit to attend *all scheduled online sessions* and *fully participate* in all class assignments. Sorry, participants *cannot* designate a substitute person for any part of the training.

### HOW TO APPLY

As soon as your application is approved, you can then submit payment of \$200 or \$300 to reserve your seat.
