Organizations applying for grants must be able to  
provide a valid W-9, a completed and submitted  
990, a copy of their IRS determination letter, and  
must be in good standing with the IRS.

**Areas of Interest:**

The Vilcek Foundation was established in 2000 with the mission to celebrate and raise awareness of immigrant contributions to the arts, culture, and society in the United States, and to foster appreciation for the arts and sciences more broadly.

Grantmaking is a vital part of how the foundation pursues its mission. Through our grants, we support organizations and projects whose mission and vision aligns with our own. Our grants empower nonprofits to expand their reach, engage diverse audiences and partners, and to advance their missions. The foundation is committed to working with organizations who take a unique approach, and exemplify best practices in their field.

The Vilcek Foundation hosts an open call for grant applications once per year. Our most recent cycle closed on June 30th, 2025, and we are in the process of reviewing all applications received. Our next grant cycle will open on September 1, 2025, with a deadline of June 30th, 2026.

Elimination of health disparities targeting the diseases and conditions that are drivers of excess death in Ohio's racial and ethnic populations.

**Four Grant Types:**

**1. Mini Grants:**

Minority Health Month  
\$4,000 (2 events in April)

**2. Miscellaneous Supplemental Grants:**

\$15,000 (1-day Conference)  
\$25,000 (2-day Conference)  
\$25,000 (Major Health Screening Event – must include follow up)

**3. Lupus Grants:**

Optimal Health Support Group with evaluation implementation.  
\$19,000 per year

**4. Demonstration Grants:**

Prevention of: Cardiovascular Disease, Type 2 Diabetes, Cancer (breast, lung, mouth, prostate), Infant Mortality (doula model), substance abuse (grades 4-12), and violence (grades 4-12).  
Evaluation must include improvements in health outcomes, birth outcomes, health status, HP 2030 and ROI.  
\$100,000 per year

**5. Infant Mortality HUB Model Grants:**

Requires implementation of the Pathways Community HUB Model, use of approved data vendor.  
Evaluation must include improvements in health outcomes, birth status, HP2030 metrics and ROI.  
\$290,000 – \$390,000 per year

### **Areas of Interest:**

The Community Foundation of Central Georgia works to improve the quality of life in 21 counties in the central Georgia region.

The Foundation provides support to organizations through the following grant programs:

#### Nonprofit Grant Program

This program provides grants of up to \$25,000 (with an average of \$10,000 to \$15,000) for projects designed to improve the quality of life in central Georgia, with emphasis on Bibb County.

Areas of interest include, but are not limited to:

- education;
- children, youth, and families;
- community and economic development;
- the environment;
- health;
- historic preservation;
- social services; and,
- arts and culture.

Priority is given to projects that:

- reach a broad segment of the community;
- have an ability to scale proven solutions to make a larger impact;
- improve organizational efficiency;
- promote matching gifts or enhance fundraising capabilities;
- collaborate with other nonprofit groups to provide innovative, more efficient approaches to solving community issues; and,
- encourage self-help or self-sufficiency on the part of disadvantaged or disabled individuals.

The Foundation considers applications from faith-based organizations for non-sectarian community outreach programs.

#### Knight Foundation Fund for Milledgeville

This fund supports nonprofit organizations that are based in or doing work in Milledgeville and Baldwin County and whose project creates an informed, engaged community. Specifically, the focus is on investments that attract, retain, and harness talent; that expand opportunity by increasing entrepreneurship and economic mobility; and that support civic infrastructure to accelerate the growth of ideas and bring people from diverse social and economic backgrounds together.

#### Dunlap Williamson Fund

This fund supports nonprofit organizations in Bibb County and the contiguous counties. Areas of particular interest include healthcare, education, family services, and youth welfare.

#### George E. Hatcher and Ann Williams Hatcher Foundation

This foundation supports nonprofit organizations in Bibb County and the contiguous counties that provide for the relief of human suffering due to disease, ill health, physical weakness, physical disability, or physical injury. The Foundation aids in the promotion and prolongation of life and to support the principle of dying with dignity. Areas of particular interest include children and youth, health, and human services.

#### Macon Area Habitat for Humanity Sustainability Fund

This fund supports quality of life programming that is open to all residents in Macon Area Habitat for Humanity's focus neighborhoods, with preference given to projects in Lynmore Estates. Projects must have a positive impact on the neighborhood and should have a plan for future sustainability if it is not a one-time event. Grants range up to \$500.

#### Ozzy's Fund

This fund provides grants of up to \$2,500 to organizations that directly promote the welfare of animals in central Georgia and throughout the state.

#### Perot-Fiero Foundation Fund

This fund supports organizations and churches that provide services to the community such as tutoring, meal or feeding programs, transportation, assistance to the physically or mentally disabled, and home repairs for those in need (through organizations, not to individuals).

#### Clayton and Carol Paul Fund

This fund provides grants of up to \$2,000 to animal humane societies, animal shelters, animal adoption agencies, low-cost spay-neuter clinics, individual wildlife rehabilitators, as well as other deserving animal welfare organizations in central Georgia.

#### Linda Harriet Lane Fund

This fund supports Bibb County projects that support the advancement of education, improvement of the

arts community, improvement of the health and recreation of the community, or otherwise benefit the community as a whole. The average grant is \$10,000.

Carling Memorial Foundation Fund

This fund supports projects that benefit the health and well-being of children in Bibb County. The average grant is \$1,000.

Central Georgia Empowerment Fund

This giving circle supports the inclusion of Black leadership and nonprofits serving the Black community. Grants range up to \$6,000.

Conversation to Action Grants

On the Table participants are eligible to apply for mini-grants to strengthen community, deepen civic involvement, and cultivate new ideas developed during their conversations. Grants range from \$100 to \$1,000.

Lamar Gives 365

This program supports non-sectarian community projects in Barnesville-Lamar County.

Community Foundation of Coffee County

This foundation provides grants to nonprofit organizations for projects in Coffee County and the immediate surrounding area.

Community Foundation of Fort Valley

This foundation provides grants averaging \$2,500 to nonprofit organizations for projects in Fort Valley and the immediate surrounding area.

Macon Violence Prevention Grant Program

This program supports local charitable organizations in their efforts to reduce violent crime in Macon-Bibb County.

High Five

This program allows nonprofits to request funding to support unique and tangible items beyond an organization's operating budget.

Note: The Foundation also administers a number of scholarship funds for area residents.
